

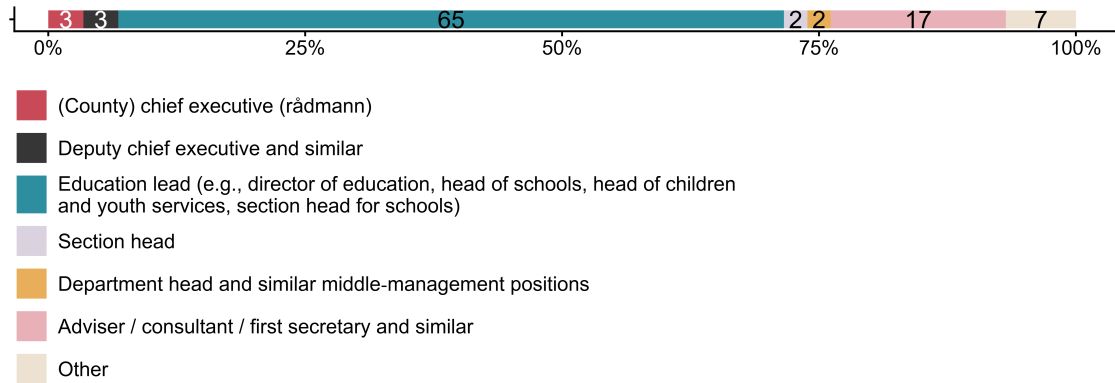

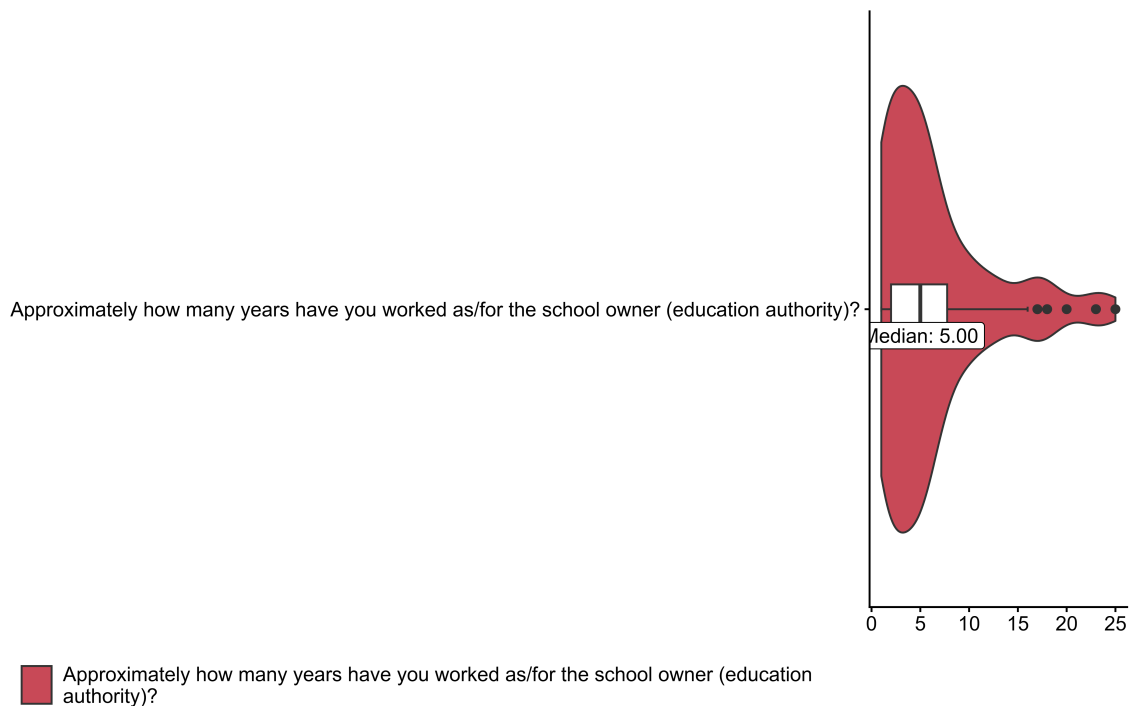

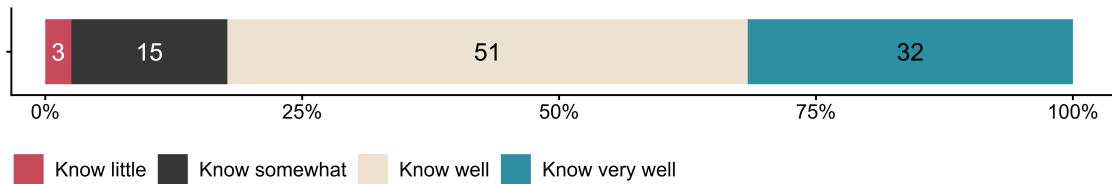


Figure 3: How familiar are you with what is written about public health and life skills (FoL) in LK20?. N = 79, Figurdata (XLSX), PNG. (SEQ8)

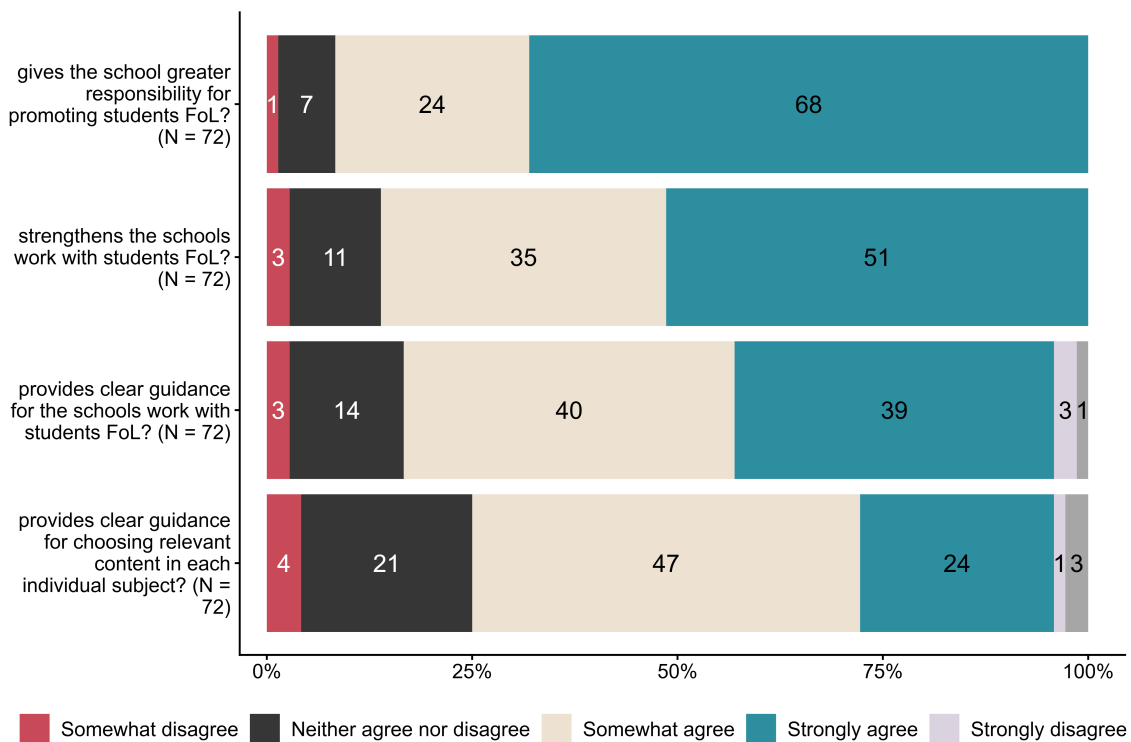
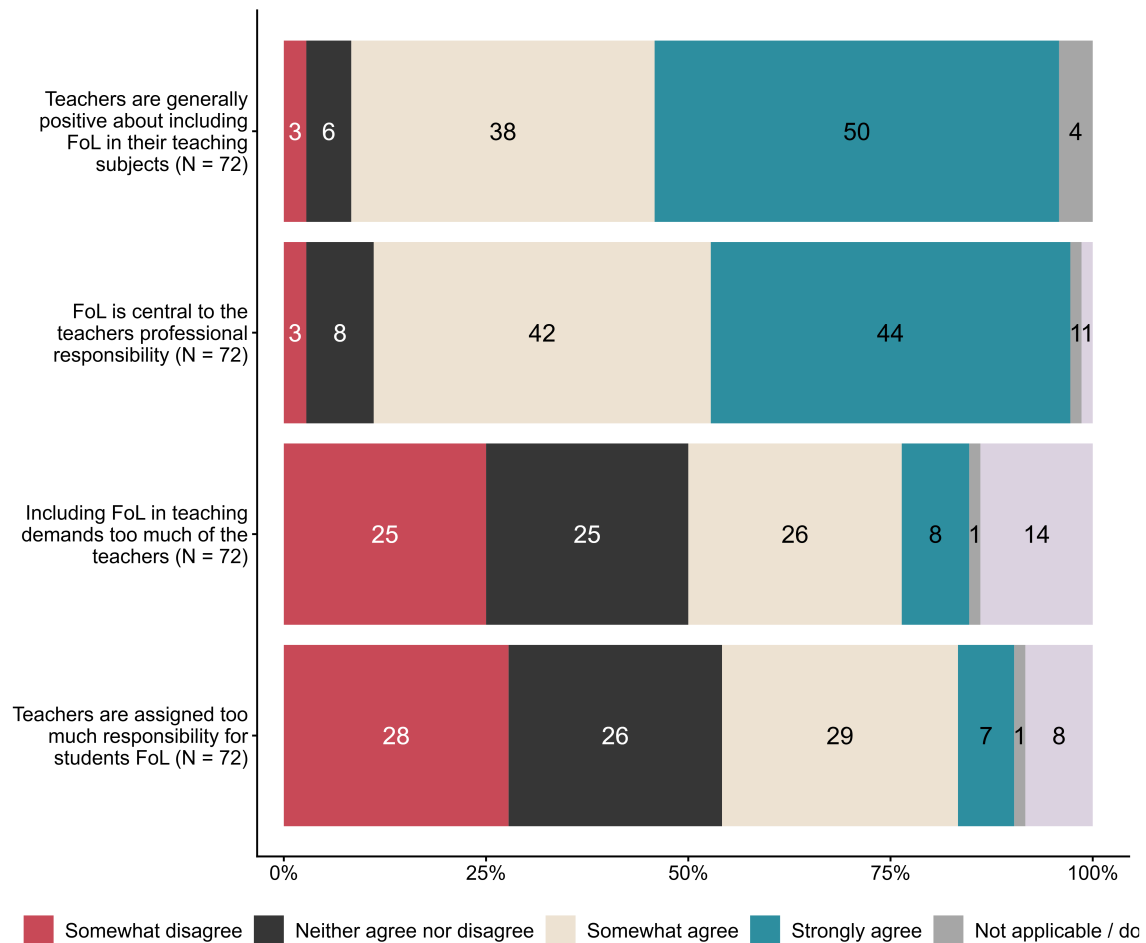


Figure 4: To what extent do you agree that the introduction of public health and life skills (FoL) in LK20. N = 72, Figurdata (XLSX), PNG. (SEQ9_1,SEQ9_2,SEQ9_3,SEQ9_4)

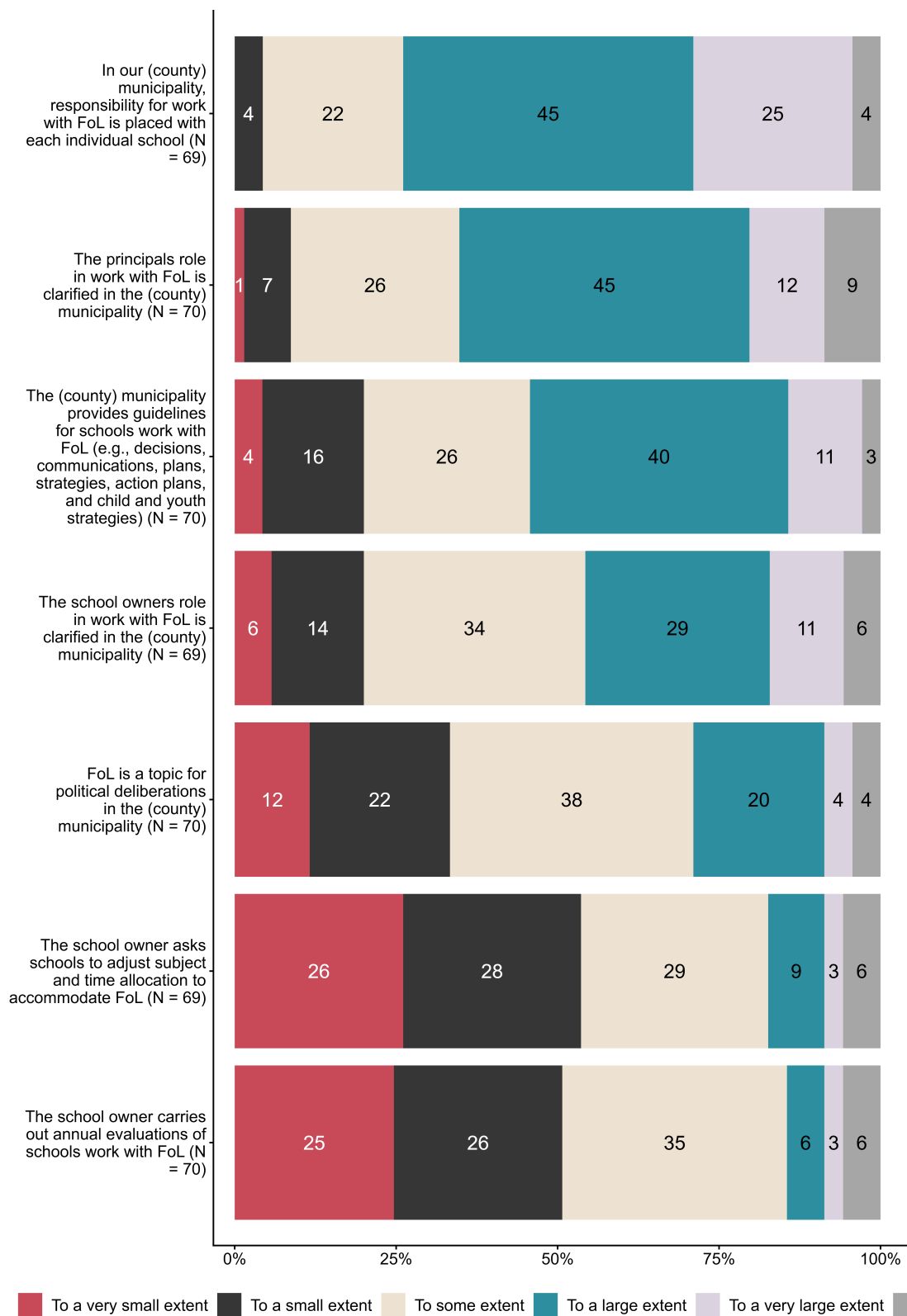
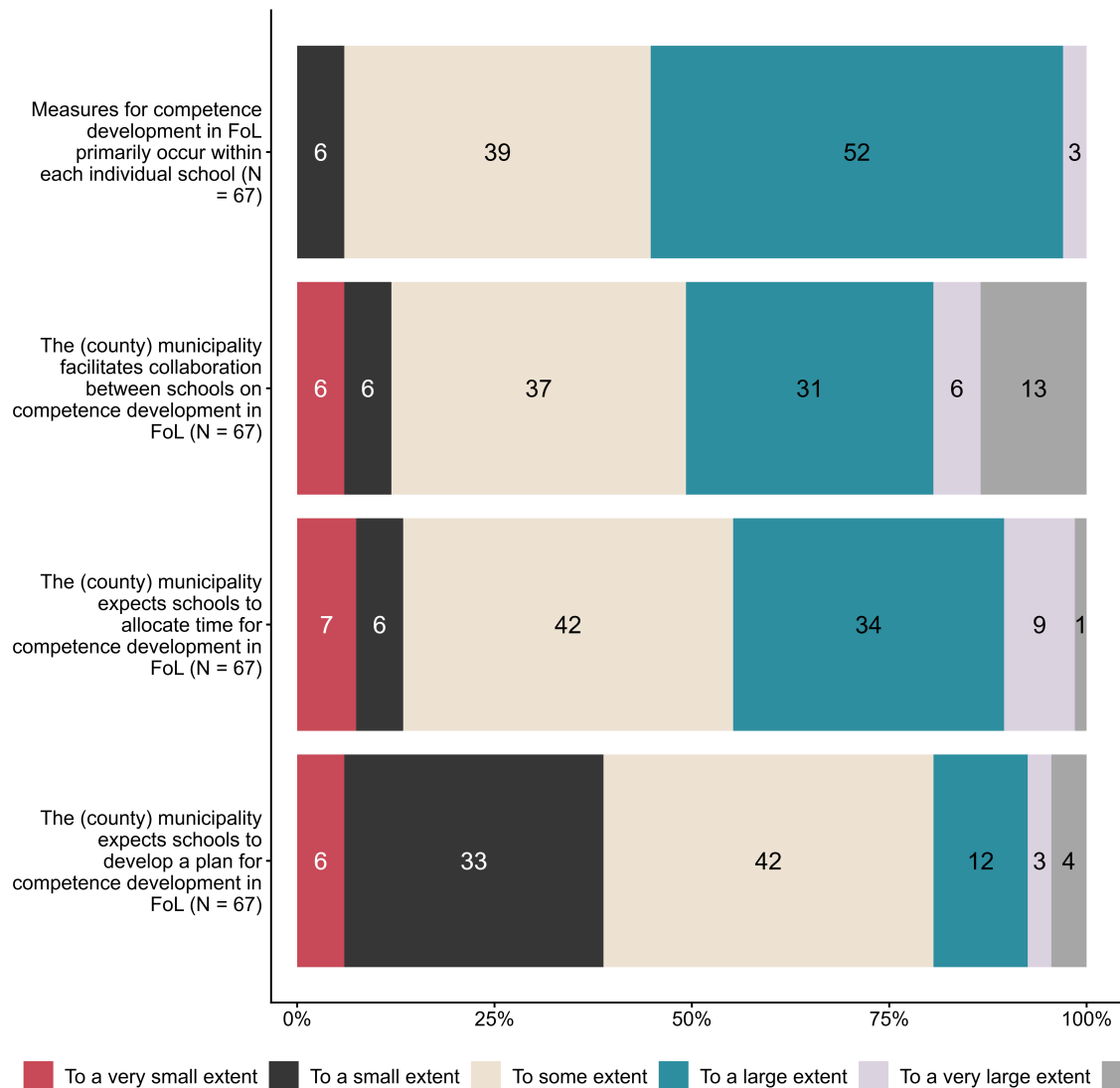


Figure 6: Below we have listed some statements about work with public health and life skills (FoL) carried out by the school owner. To what extent do they fit your (county) municipality? N = [69–70], Figurdata (XLSX), PNG. (SEQ12_1,SEQ12_2,SEQ12_3,SEQ12_4,SEQ12_5,SEQ12_6,SEQ12_7)

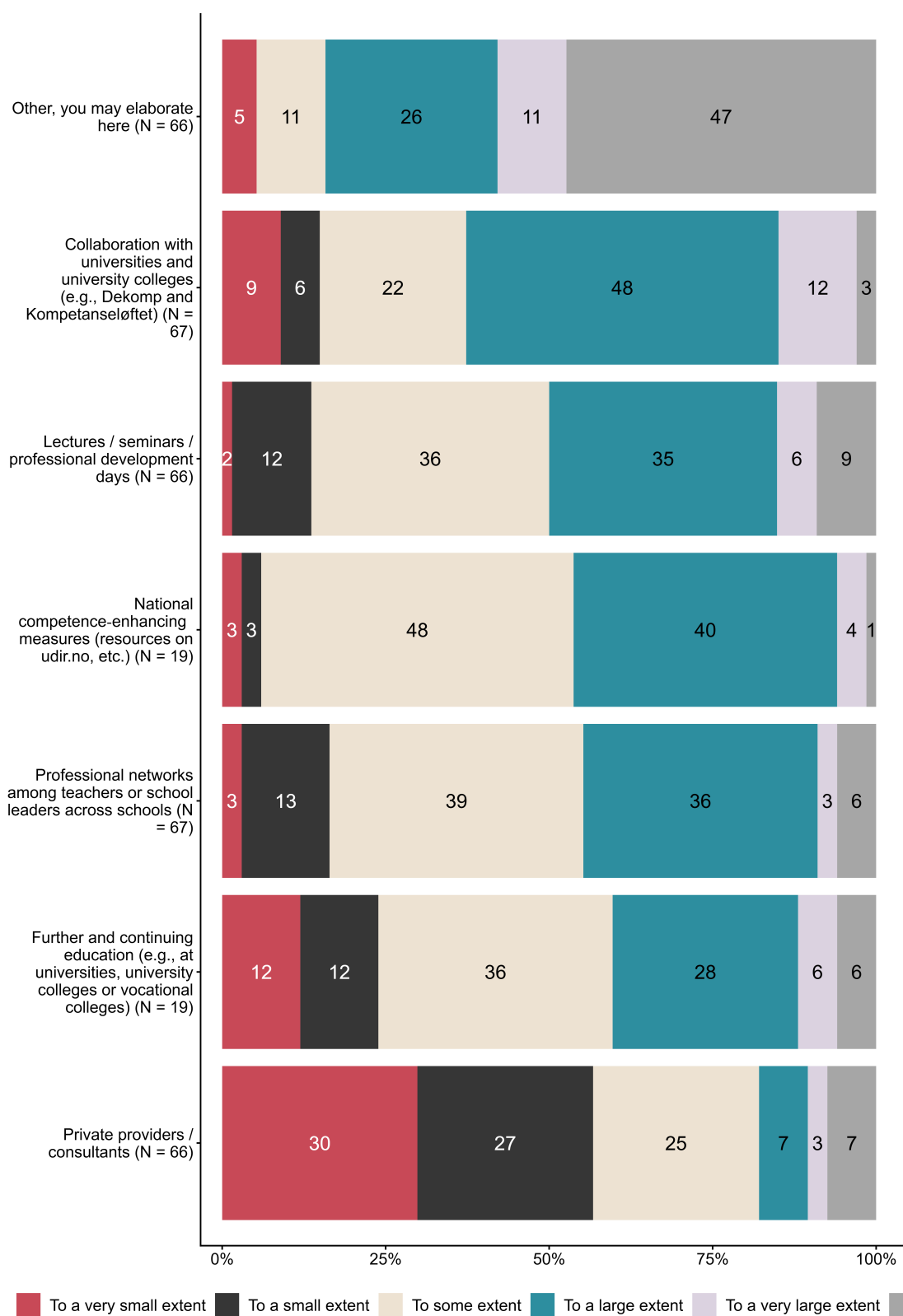
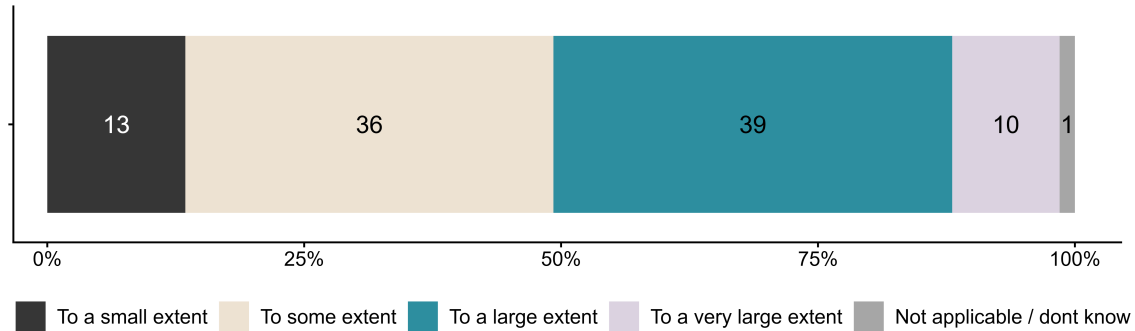


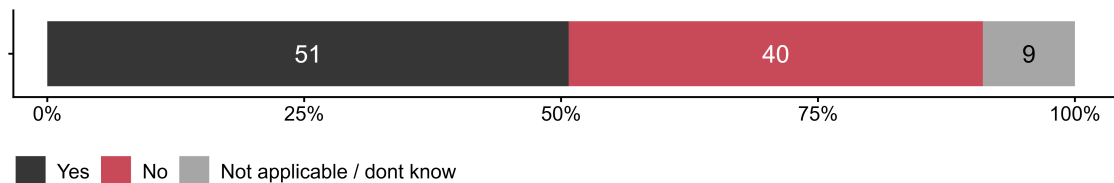
Figure 8: To what extent have staff in schools in your (county) municipality been offered the following competence-enhancing measures in public health and life skills? N = [19–67], Figurdata (XLSX), PNG. (SEQ14_1,SEQ14_2,SEQ14_3,SEQ14_4,SEQ14_5,SEQ14_6,SEQ14_7)

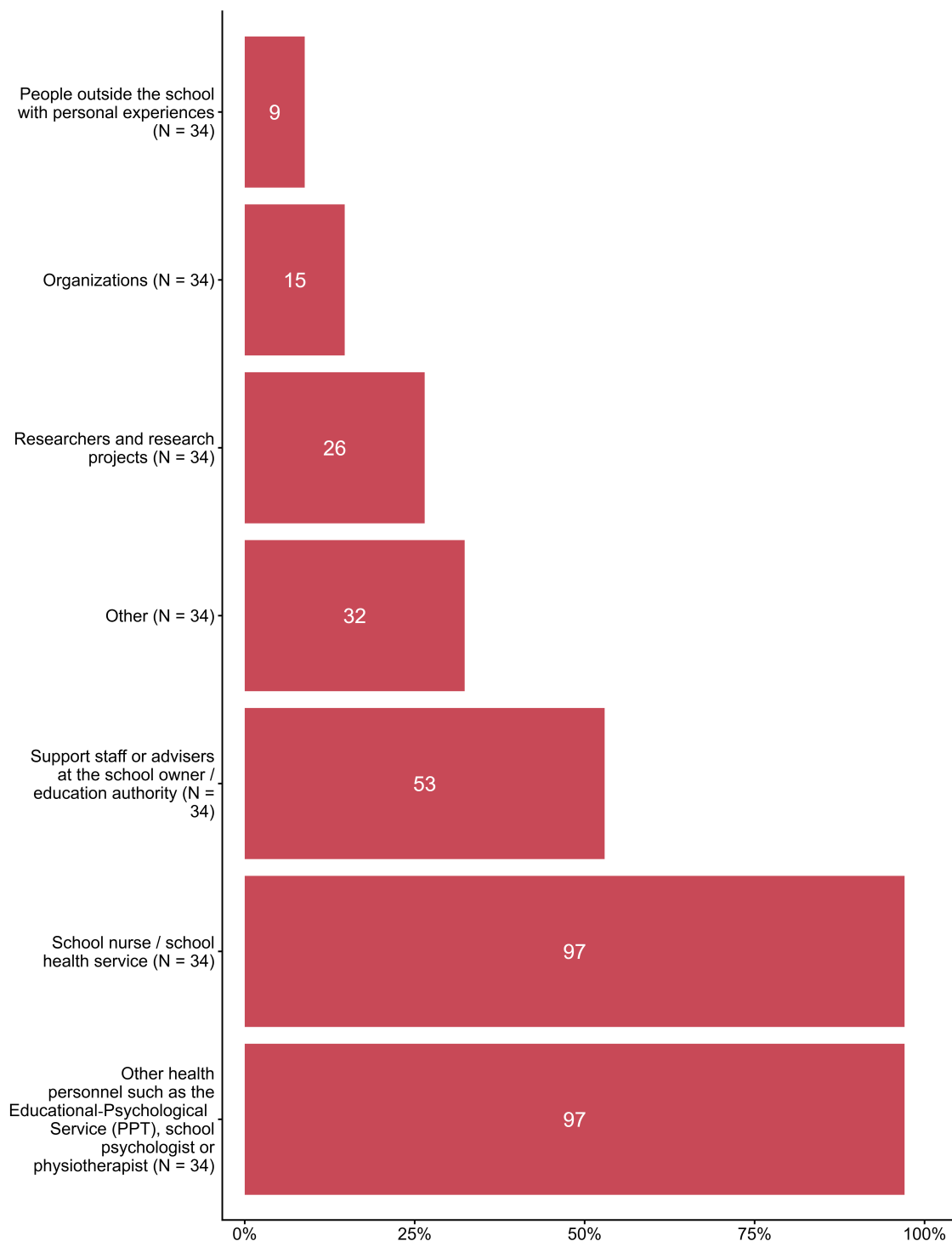

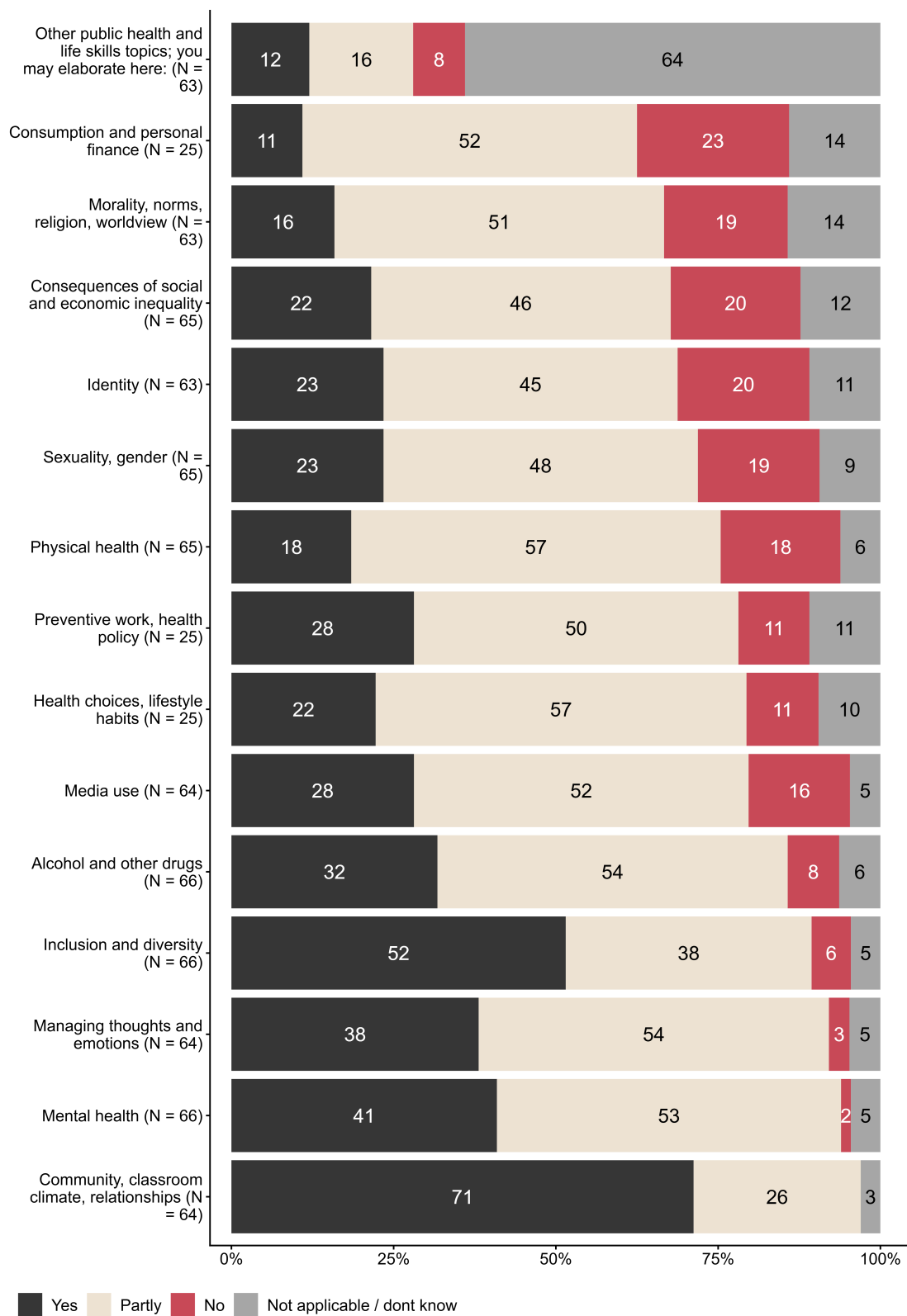

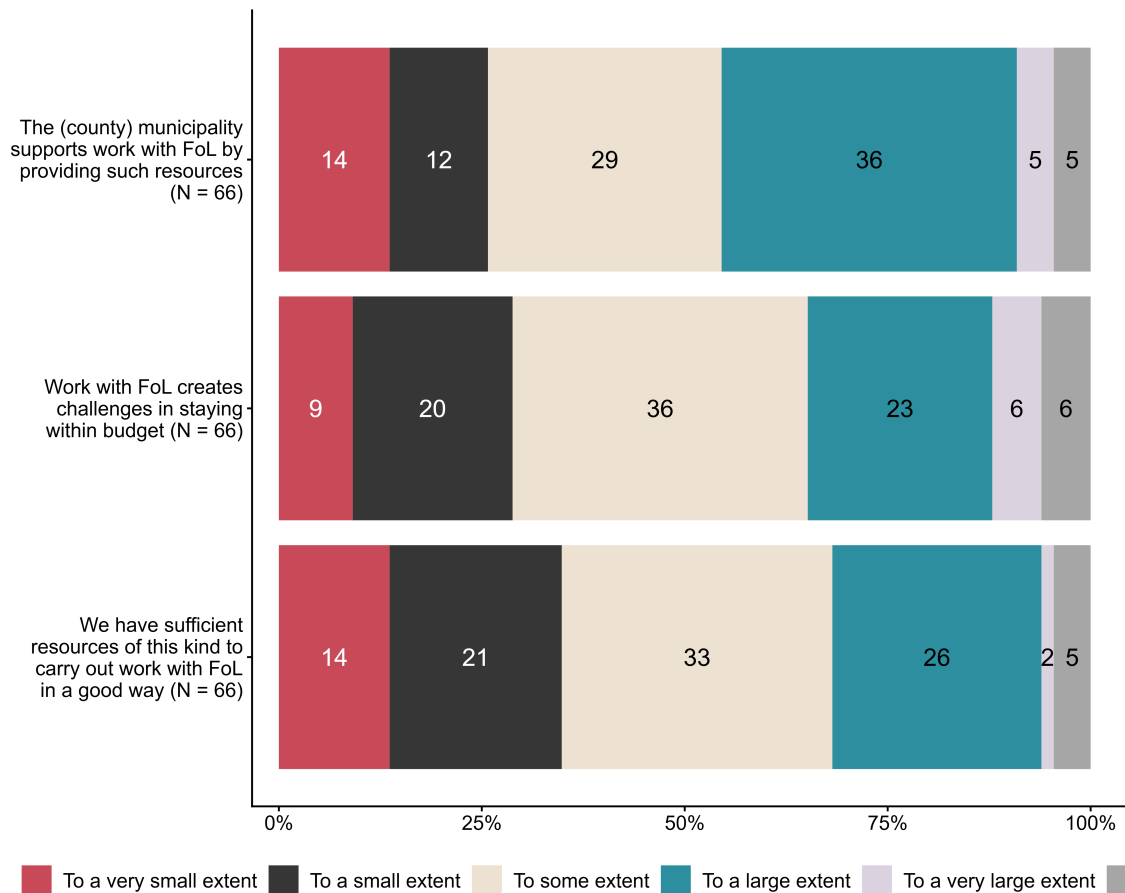

Figur 12: *Does the (county) municipality offer professional development for school staff on any of*

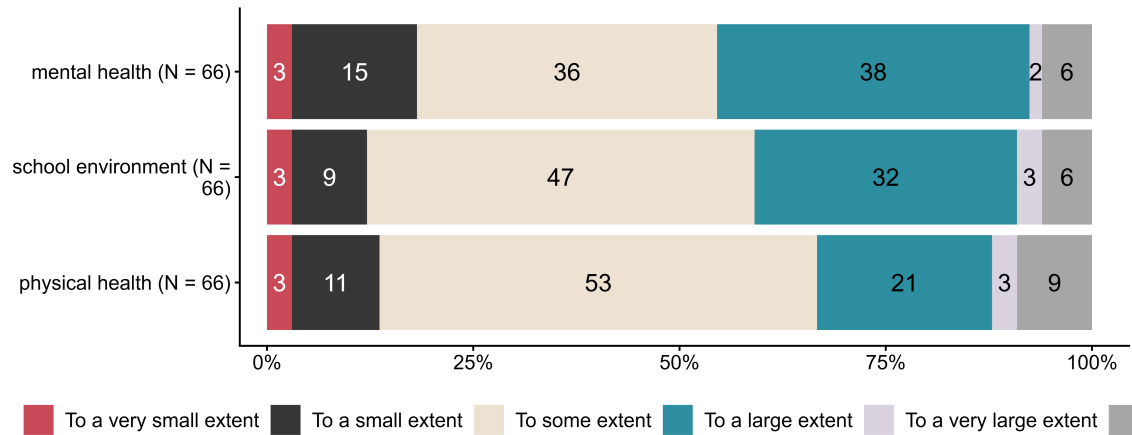
